## **REPORT FROM THE DIRECTOR AND PRESIDENT**

The Association of Marshall Scholars (AMS) continued to advance its core strategic objectives over the past year: working to strengthen the Marshall Scholarship, build US-UK ties and increase Marshall alumni community engagement and visibility.

## ENGAGEMENT

In 2022, the AMS benefited from strong alumni engagement: over 30% of our community members volunteered their time, expertise and support in leadership roles, including serving on the AMS Advisory Board, Board and Executive Committee, Director's Circle, and as regional events coordinators, outreach volunteers, program speakers, and as members of Application Reading and Selection Committees.

## SCHOLARSHIP

The UK Government announced 40 new winners of the Marshall Scholarship in December 2022. The 2023 class includes accomplished authors, astrophysicists, human rights and public health researchers, among this class of young scholars. Notably, 85% of the 2023 class intend to pursue public service careers in the US following their time in the UK, including representatives from the US Military Academy and US Air Force Academy who will take up active duty upon completing their studies. To help bolster the Scholarship experience, through the generosity of alumni, the AMS was able to offer three grants to all current scholars. First, the Marshall Xtra grant (of 1,000 GBP per scholar), enables each of the eighty-five enrolled Scholars in 2022 to further enhance their experience of British life and culture during their Marshall Scholarship program. Second, the AMS Marshall Plus grant supports class camaraderie-building activities, such as Thanksgiving dinner together, hiking trips or theater excursions. Third, since COVID, the AMS has offered a new AMS Emergency Fund to support Scholars during unforeseen emergencies that may seriously affect Scholars' ability to conduct their research overseas. The AMS also provides direct funding for Marshall scholarships through its alumni Endowed Marshall Scholarship and additional grants.



"The Marshall Xtra Stipend was essential this year as I navigated living in the UK under the circumstances of a pandemic. Whether that was ordering delivery during self-isolation, arranging for safer means of transportation, or booking an Airbnb to quarantine, the extra money alleviated pressure and anxiety. It enabled me to continue working on my PhD from Cambridge, rather than the U.S., which not only facilitated my progress on my thesis but allowed me to continue to foster relationships and ties to this place I now consider to be my home. ## PROGRAMMING

In 2022, the AMS had approximately 1,300 attendees at its programs. These included 25 regional, virtual events and partnership programs co-hosted with the UK Foreign, Commonwealth and Development Offices, the American College of Trial Lawyers, the Truman Foundation, Rhodes Trust, and the Gates Trust. Additional class reunions, and collaborations with British Consulate Generals and the British Embassy took place throughout the year.

### FORUM ON THE RULE OF LAW

The AMS and the American College of Trial Lawyers (ACTL) hosted top American and British Justices, judges, lawyers, and experts for a three-day Forum on the Rule of Law, May 3 – 5, 2022, at the Supreme Court of the United States. This program built upon the half-day, precursor dialogue co-hosted by the AMS and ACTL online September 24, 2021, during COVID, bringing together distinguished American and British judges, lawyers, and legal experts to discuss a series of topics including: COVID and the Courts, Separation of Powers, and Free Speech and the Internet. For the three-day Forum on the Rule of Law taking place at the United States Supreme Court, participating US and UK delegations held a series of conversations on critical legal issues in a post-pandemic world, including the rule of law and national security, separation of powers, free speech and the Internet, human rights and civil liberties, climate and the courts, and other topics.


## COMMUNICATIONS

### SOCIAL / DIGITAL MEDIA AND MARSHALL COMMUNICATIONS

Visibility for the Association's work has grown over the past four years. The AMS has seen an approximately 60% increase in Twitter following and the rebranded AMS website -- http://marshallscholars.org -- has had over 117% year over year increase in visitors since its June 2020 launch (74% from the United States, ~16% from the United Kingdom). Professionalized and regular communications now include monthly ebullitions for alumni, AMS Annual Reports, annual national polling with Emerson College, one-off reports for the UK government, and the Marshall Alumni Newsletter. The 2022 June Marshall Alumni Newsletter, was the first in a new AMS brand template designed by Katie Clark (2005) and was produced by new Editor in Chief Maureen Hamon of Dog Ear Creative, focused on Marshalls and The Elements.

#### PRINT & NATIONAL MEDIA

For the fifth consecutive year, the AMS commissioned a national poll by Emerson College with the purpose of (1) probing current US perceptions of transatlantic ties, and (2) assessing Marshall Scholarship brand awareness by the US public. The AMS press release with results from the national poll was picked up by 343 outlets / news sources including the Associated Press, with a potential total audience of 213 million.

As in previous years, our national poll also included questions to assess public brand awareness of the Marshall Scholarship in relation to comparable scholarship schemes. In 2022, 43% of Americans polled had never heard of the Marshall Scholarship, as compared with 38% of the respondents who had not heard of the Scholarship in 2018. The Marshall Scholarship is still significantly less well known than the Rhodes (26% had not heard of the Rhodes in 2022, 17% in 2018) and the Fulbright (only 34% had not heard of the Fulbright in 2022, 23% in 2018). As compared with 2018, the net positive ("somewhat" and "very positive") views of the Marshall Scholarship has also gone down from 39% to 31% positive. The year-on-year research continues to underscore a significant challenge for the Scholarship: how to build more awareness of the program and understanding of the impact of its alumni.

## DEVELOPMENT

### 2022 ANNUAL GIVING

In 2022, the AMS received donations from more than 350 scholars and partners, including 75 new donors, 6 foundations, and one corporation. Over 90% of AMS donations came from small donors, 99% of all Marshall classes participated in giving, and 31% of these classes had a participation rate of 20% or higher – with the class of 1956 leading the way at a 50% participation rate. We are incredibly grateful to our young alumni who are participating at unprecedented rates.

### MARSHALL 2020 CAMPAIGN

The AMS successfully completed its Marshall 2020 campaign, which helped raised commitments in cash, matches, multiyear pledges and legacy giving of nearly \$7.6 million dollars between 2019-2022. Through the generosity of alumni and additional significant supporters, the AMS has been able to surpassits initial goal and bring the campaign to completion early and over the initial targeted amount. Through a generous anchoring challenge grant by Reid Hoffman CBE (1990), and additional matching grants by Finistere Charitable Foundation, Anonymous (1983), and Marcus Ryu (1995), we were given the opportunity to match more than \$2.25 million dollars of campaign giving.

Over the course of the campaign, ~30% of the membership, as well as donors who are not Marshall Scholars, have joined together to support our fundraising efforts, including 213 new donors and 15 foundations.

We are grateful to the efforts of class chairs and are pleased to acknowledge those leading engagement included the class of 1956 (100% participation), 1960 (74% participation), 1957 (57% participation), 1958 (50% participation), and 1989 (50% participation). Younger scholars also gave generously, with 30-40% participation by the classes of 2002, 2004, 2005, 2007, 2010, and 2015. And the scholars from our most recent classes of 2018 and 2019 have begun to engage in the efforts of the AMS as well.

We wish to express our deepest gratitude to our major benefactors who have contributed pledges at the Benefactor level (\$250,000+); the Leaders' Circle (\$100,000+); Fellows' Circle level (\$25,000+); the Supporters' level (\$5,000+); the Contributors' level (\$1,000+); and through the Marshall Legacy Fund (Planned-Giving), which is now at \$2.5M. We are also very grateful to all those who gave -- at any amount -- as a Friend to the AMS (\$1+) through our Annual Appeals.

The Marshall 2020 campaign is a significant step towards securing the future of the Association and the Marshall Scholarship. Campaign funds are helping to strengthen the Scholarship, build a more vibrant and visible Marshall community and actively support ties between the United States and the United Kingdom with scholars and their broader networks through exchanges, forums, fellowships, new initiatives and grants. These funds have already helped the AMS develop significant programmatic activity, communications, and new opportunities for the Scholarship and alumni over the past three years. They will enable us to continue to develop these initiatives in the near future.
